**4. FIRST AID MEASURES**

**4.1 Description of first aid measures**

<b>Eye</b>	If in eyes, hold eyelids apart and flush continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre, a doctor, or for at least 15 minutes.
<b>Inhalation</b>	If inhaled, remove from contaminated area. Apply artificial respiration if not breathing.
<b>Skin</b>	If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. Continue flushing with water until advised to stop by a Poisons Information Centre or a doctor.
<b>Ingestion</b>	For advice, contact a Poisons Information Centre on 13 11 26 (Australia Wide) or a doctor (at once). If swallowed, do not induce vomiting. Ingestion is considered unlikely due to product form.
<b>First aid facilities</b>	None allocated.

**5. FIRE FIGHTING MEASURES**

**5.1 Extinguishing media**

Dry agent, carbon dioxide, foam or water fog. Prevent contamination of drains and waterways.

**5.2 Special hazards arising from the substance or mixture**

Highly flammable aerosol. May evolve toxic gases (carbon oxides, hydrocarbons) when heated to decomposition. Aerosol may explode at temperatures exceeding 50°C. Eliminate all ignition sources including cigarettes, open flames, spark producing switches/tools, heaters, naked lights, pilot lights, mobile phones, etc when handling. Aerosol cans may explode when heated above 50°C.

**5.3 Advice for firefighters**

Evacuate area and contact emergency services. Toxic gases may be evolved in a fire situation. Remain upwind and notify those downwind of hazard. Wear full protective equipment including Self Contained Breathing Apparatus (SCBA) when combating fire. Use waterfog to cool intact containers and nearby storage areas.

### 7.1 Precautions for safe handling

Not classified as a Carcinogen - Piperonyl butoxide is classified by IARC as a Group 3 - Not classifiable as to its carcinogenicity to humans.

**Eye** Irritant. Contact may result in irritation, lacrimation, pain and redness.

**Inhalation** Low to moderate irritant. Over exposure may result in irritation of the nose and throat, with coughing. High level exposure may result in breathing difficulties.

**Skin** Irritant. Contact may result in irritation, redness, rash and dermatitis. May cause sensitisation by skin contact.
