DIRECTIONS FOR USE

Shake can well before use. Hold can upright while spraying and hold about 15 to 20 cm from the surface to be sprayed. Avoid using on plastic surfaces.

Ants Cockroaches	For residual control, spray as a surface application up to but not exceeding the point of run off onto surfaces and into cracks and crevices where insects are likely to rest, harbour, live and breed. Use the crack and crevice extension tube to direct spray into cracks, crevices and other hard to reach places. Clearout Plus IGR Aerosol Insecticide can also be applied directly as a spot treatment to live insects.
House flies	Apply to surfaces where flies are likely to rest. For outdoor fly control, apply to surfaces where flies tend to be a nuisance. Apply spray up to but not exceeding the point of run off. Clearout Plus IGR Aerosol Insecticide can also be applied directly as a spot treatment.
